TERMS & CONDITIONS

1. All reservations are subject to availability at the time of booking and must be made through AMAZING CHARTERS. Yachts are available November through July excluding Christmas and New Year. It is recommended to make reservations up to 6 months in advance for vacations between December and March.
2. The package includes the services of a Captain and Crew, meals, drinks and all expenses related to running of the vessel and use of on-board sports equipment. Charter does not include premium beverages and fine wines, excessive alcoholic consumption, off yacht excursions, dockage, telephone, airport transfers and crew gratuities, or similar expense incurred by the guests.
3. Force majeure is defined as any cause attributed to acts of GOD, accidents, weather or other omissions beyond the reasonable control of a party, and not caused by that party's negligence. No warranty is made as to the suitability of weather with respect to this charter. If a Named Storm threatens or is forecast to threaten the expected location of the charter yacht, as determined by the Captain in his/her sole discretion, the Captain shall have the option of terminating or canceling the charter any time that he/she deems necessary. No cash refund is provided for cancellation due to weather.
4. The vacation must start within one year from the auction.
5. Any upgrades or deviation from the package might incur additional expenses
6. Purchaser is responsible for any federal, state or local income or other taxes not included in the package or gratuities, if applicable.
7. The original winner letter and Redemption Code must be presented to AMAZING CHARTERS to initiate your reservations.
8. Certain restrictions may apply and this trip is not exchangeable, refundable, transferable or redeemable for cash
9. Trip may be modified due to Acts of God, war, terrorism, or other items beyond the Program's control.
